
CCICOMPUTER SERVICES, INC. END-USER SOFTWARE LICENSE AGREEMENT

Software License for CCICOMPUTER SERVICES, INC. Products

IMPORTANT - READ CAREFULLY BEFORE USING THIS SOFTWARE: This License Agreement for CCICOMPUTER SERVICES, INC. Products ("License Agreement") is a legal agreement between you (either an individual or an entity) and CCICOMPUTER SERVICES, INC., Inc., its suppliers, and its licensors (collectively "CCI") for the CCICOMPUTER SERVICES, INC. software. (For the purpose of this agreement, "CCI" shall include CCICOMPUTER Services, Inc., its suppliers, and its licensors. Also for the purpose of this agreement, "CCI and/or its Employees, Officers, Directors, Suppliers, and Licensors" shall include the Employees, Officers, Directors, Suppliers, and Licensors of CCICOMPUTER SERVICES, INC., Inc, the Employees, Officers, Directors, Suppliers, and Licensors of CCICOMPUTER SERVICES, INC., Inc.'s suppliers, and the Employees, Officers, Directors, Suppliers, and Licensors of CCICOMPUTER SERVICES, INC., Inc.'s licensors.) This Agreement states the terms and conditions upon which CCI offers to license the software accompanying this License Agreement whether on disk, CD-Rom, electronically downloaded, or on any other media or in any other form together with all related documentation and accompanying items including, but not limited to, the executable programs, libraries and data files associated with such programs (collectively, the "Software"). The Software may include any of the following products, produced by either CCICOMPUTER SERVICES, INC., Inc., its suppliers, and/or its licensors, including but not limited to any combination of such products and Beta versions of the products (collectively, "CCI Products") as well as products to be introduced in the future: CCI2K Automobile Rater, CCI2K Homeowner, CCI2K Motorcycle, CCI2K Dwelling, CCI2K Policy Manager, CCI2K Communications, CCI2K Application, CCI2K Bridging Programs and ACORD Forms. By clicking on buttons that indicate you accept these terms, installing, copying or otherwise using the Software; you agree to be bound by the terms of this License Agreement. IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENSE AGREEMENT, CLICK ON THE "CANCEL" BUTTON OR THE "NO" BUTTON AND/OR DO NOT INSTALL OR USE THE SOFTWARE.

YOU AGREE THAT YOUR USE OF THE SOFTWARE ACKNOWLEDGES THAT YOU HAVE READ THIS LICENSE, UNDERSTAND IT, AND AGREE TO BE BOUND BY ITS TERMS AND CONDITIONS.

LICENSE

1. Grant of License.

The Software is licensed, not sold, to you for use only under the terms of this Agreement. You own the computer disk or other media on which the Software is originally or subsequently recorded or fixed; but, as between you and CCI, CCI (for the remainder of this section only, "CCI" shall refer to individual members of "CCI", as appropriate) retains all title to, ownership of, rights of, and intellectual property rights in and to the Software and Documentation and reserves all rights not expressly granted to you.

2. Limitations on Using and Copying the Software.

You may not use or distribute the Software for any unlawful purpose.

You agree that you shall only use the Software and Documentation in a manner that complies with all applicable laws in the jurisdictions in which you use the Software and Documentation, including, but not limited to, applicable restrictions concerning copyright and other intellectual property rights.

The sale of and/or distribution of copies of the Software is strictly forbidden. It is a violation of this License Agreement to loan, rent, lease, borrow, or transfer the use of the Software.

3. Decompiling, Disassembling, or Reverse Engineering.

You may not decompile, disassemble or otherwise reverse engineer the Software, or engage in any other activities to obtain underlying information that is not visible to the user in connection with normal use of the Software. This License Agreement does not grant you any intellectual property rights in the Software.

4. Transmission of User Profile

When connected to CCI's BBS service or CCI's web site, CCI may gather identifying information about the computer running the Software, as well as the setup parameters and usage information of the Software. This information allows CCI to properly bill for its services, to provide a useful product and service, and to plan for future enhancements and services. CCI will keep this information confidential except that it will be supplied to prosecuting or regulatory authorities in connection with fraud or other investigations concerning violations of this agreement.

TERMINATION

The license granted to you is effective until terminated. You may terminate it at any time. The license will also terminate automatically without any notice from CCI if you fail to comply with any term or condition of this Agreement. Upon termination, CCI may also enforce any rights provided by law. The provisions of this Agreement that protect the proprietary rights of CCI will continue in force after termination.
